PENNSYLVANIA ADMINISTRATIVE LAW

Rohrbaugh v. Pennsylvania Pubic Utility Commission: The Pennsylvania Supreme Court held that Section 1501 of the Public Utility Code does not require a utility company who disconnects service to the property at a tenant/ratepayer's request, consequently causing substantial damage to the property, to first notify the landlord/property owner who was not the ratepayer and who had not entered into a contractual arrangement with the utility to continue service. 795

Housing Authority of the County of Chester v. Pennsylvania State Civil Service Commission: The Pennsylvania Supreme Court held that the State Civil Service Commission has standing to enforce the veterans' preference provisions of the Military Affairs Act sua sponte, and that a housing authority violated the Act when it failed to first offer the open executive position to a qualified veteran candidate. ... 800

PENNSYLVANIA CONSTITUTIONAL LAW

Wetz v. Chapman Township: The Pennsylvania Supreme Court held that a plaintiff who seeks monetary damages under the Pennsylvania Human Relations Act is not entitled to a jury trial. 807

In the Interest of F.B.: The Pennsylvania Supreme Court held that a knife seized from a high school student, during a search of all students for weapons as a precondition of entry, was the product of a lawful search under both the United States Constitution and the Pennsylvania Constitution. 811

Denbow v. Borough of Leetsdale: The Pennsylvania Supreme Court held that principles in the state constitution relating to the General Assembly’s legislative authority to appropriate funds from the state treasury apply equally to municipalities when appropriating funds from local treasuries. 815

Commonwealth v. State Board of Physical Therapy: The Pennsylvania Supreme Court held that Pennsylvania’s Physical Therapy Practice Act, which prohibits chiropractors who are not licensed physical therapists from advertising that they perform physical therapy services, does not unconstitutionally infringe on their freedom of expression. 818

Dial v. Vaughn: The Pennsylvania Commonwealth Court held that the requirement that an inmate submit a blood sample for DNA identification as a condition for parole did not violate the separation of powers doctrine, was not an unconstitutional ex post facto law, and did not constitute an unconstitutional search and seizure. 822

Richland School District v. County of Cambria Board of Assessment Appeals: The Pennsylvania Commonwealth Court held that a township and a school district possess the same procedural due process rights that individual taxpayers have to appeal an untimely decision by a tax assessment board. 826

PENNSYLVANIA CRIMINAL LAW

Commonwealth v. Gindlesperger: The Pennsylvania Supreme Court held that the warrantless use of an infrared thermal imaging device to scan a private residence for evidence of criminal activity violates the Fourth Amendment..... 829

Commonwealth v. Morgan: The Pennsylvania Supreme Court held that a criminal defendant's character witness, called to testify about the good character of the accused, may not be questioned on cross-examination about knowledge of allegations of specific prior instances of misconduct that did not result in arrest. 833

Commonwealth v. Sierra: An evenly divided Pennsylvania Supreme Court held that a police officer's continued questioning of a driver following the issuance of a traffic citation constitutes an investigative detention and if such detention is not supported by a reasonable suspicion of criminal activity, any consent obtained by the officer to conduct a search is tainted by the illegality of the detention. 836

Commonwealth v. Wright: The Pennsylvania Supreme Court held that the seizure of a weapon pursuant to a Pennsylvania statute that requires the police to seize weapons in certain cases involving domestic violence is subject to the limits of existing Fourth Amendment jurisprudence. 841

Commonwealth v. Cleckley: The Pennsylvania Supreme Court held that the federal voluntariness standard for consensual, warrantless searches satisfies the privacy requirements of the Pennsylvania Constitution. 844

Commonwealth v. Booth: The Pennsylvania Superior Court held that a fetus which has reached the stage of viability will be considered a “person” as that term is used in the Pennsylvania criminal statute punishing homicide by vehicle while driving under the influence. 847

PENNSYLVANIA EMPLOYMENT LAW

Hutchison v. Luddy: The Pennsylvania Supreme Court held that a Bishop and a Diocese were liable under the theory of negligent supervision and retention for a priest’s sexual abuse of a minor in a motel room because they both knew the priest had a propensity for pedophilic behavior, they concealed this fact and allowed the priest to have unsupervised contact with children, and the priest was able to enter the motel room only because of his status as a priest, the servant of the Bishop and the Diocese. 851

Hoffman v. Workers’s Compensation Appeal Board (Westmoreland Hospital): The Pennsylvania Supreme Court held that a workers’ compensation claimant who sustained an injury while she was off duty but present at the workplace while obtaining her paycheck was entitled to workers’ compensation benefits, despite the fact that the claimant had other options for obtaining her paycheck. 859

Commercial Credit Claims v. Workmen’s Compensation Appeal Board (Lancaster): The Pennsylvania Supreme Court held that an employer attempting to terminate worker’s compensation benefits does not have the burden of proving the

absence of a casual relationship between the work-related injury and a subsequently alleged psychiatric injury when the employer only accepted liability for the physical injuries suffered by the claimant; the employer need only prove that the physical injuries have ceased. 862

Curtis v. Workers' Compensation Appeal Board (Berley Electric Company): The Pennsylvania Commonwealth Court held that an employer met its burden of proof for its suspension of compensation benefits by proving that the employee voluntarily removed himself from the work-force by self-inflicting a gunshot wound to the head, and that the employee was not able to raise the argument that an earlier work-related back injury caused the mental imbalance that provoked the self-inflicted injury because the employee did not properly preserve this issue for appeal. 865

Urban v. Dollar Bank: The Pennsylvania Superior Court held that an employee's defamation and malicious abuse of process claims against an employer are not barred by the exclusivity provisions of the Workers' Compensation Act because the essence of those torts is to vindicate harm to one's reputation, which is not an injury under the Act. 869

PENNSYLVANIA FAMILY LAW

B.A. v E.E.: The Pennsylvania Supreme Court held that prospective adoptive parents do not stand *in loco parentis* when one parent contests the adoption. 873

Fish v. Behers: The Pennsylvania Supreme Court held that: (1) the presumption of paternity is inapplicable when the presumptive father is divorced from the mother, and (2) the mother is

estopped from seeking a determination of nonpaternity against the presumptive father when the presumptive father has held the child out as his own during the marriage. 875

Strauser v. Stahr: The Pennsylvania Supreme Court held that the presumption of paternity is applicable and irrebuttable when the marriage that the child was born into is intact. 879

Lindh v. Surman: The Pennsylvania Supreme Court held that the donor of an engagement ring is entitled to its return, or its equivalent value, even though the donor terminated the engagement. 882

PENNSYLVANIA TAX LAW

Wilson Partners, L.P. v. Commonwealth: The Pennsylvania Supreme Court held that the Pennsylvania realty transfer tax does not violate the Supremacy Clause nor the Equal Protection Clause of the United States Constitution, nor the Uniformity Clause of the Pennsylvania Constitution, where a nonexempt party is liable for realty transfer tax in a transaction entered into with a party who is tax-exempt. 887

Pennsylvania State University v. Derry Township School District: The Pennsylvania Supreme Court held that the Pennsylvania State University is not an agency of the Commonwealth, and, therefore, its medical center is subject to local real estate taxation. 891

Haller v. Commonwealth: The Pennsylvania Supreme Court held that the Pennsylvania sales tax exemption for the sale of religious publications, Bibles, and religious articles violates the Establishment Clause of the United States Constitution. 893

Unisys Corporation v. Commonwealth: The Pennsylvania Commonwealth Court held that the three-factor apportionment formula does not violate the Due Process Clause of the United States Constitution as applied to taxpayers with subsidiaries, but such taxpayers are entitled to statutory equitable relief under the special apportionment provision set forth in the Pennsylvania Tax Code. 896

PENNSYLVANIA TORT LAW

Physicians' Insurance Company v. Pistone: The Pennsylvania Supreme Court held that in seeking indemnity from an insurance carrier for a claim arising out of the delivery of "professional health care services," the actions of medical professionals will constitute such services when the act that caused the harm amounts to a medical skill associated with specialized training. 903

Leahy v. McClain: The Pennsylvania Superior Court held that the "sudden emergency doctrine" is not an affirmative defense that must be pleaded as new matter under the Pennsylvania Rules of Civil Procedure. 906

Swartley v. Hoffner: The Pennsylvania Superior Court held that the relationship between a University and a student is contractual in nature, and the student may bring a cause of action against the University for breach of contract where the college ignores the provisions of the pact contained in the written material distributed in association with the offer to confer a degree. 908

Baker v. ACandS, Inc.: The Pennsylvania Superior Court held that a court, in assessing liability among joint tortfeasors in a strict liability case, must give

effect to the terms of a “pro tanto” release when the amount of the settlement is less than the plaintiff’s total claim. 911
