



Bruce Ledewitz is the Adrian Van Kaam C.S.Sp. Endowed Chair in Scholarly Excellence and a professor of law at the [Thomas R. Kline School of Law of Duquesne University](#). He teaches in the areas of state and federal constitutional law and jurisprudence, specializing in law and religion and law and the secular. He is co-director of Duquesne Kline's Pennsylvania Constitution website.



Ledewitz [writes and speaks](#) widely on a variety of legal and religious topics, in both legal journals and popular media, including hosting the “[Bends Toward Justice](#)” podcast. In addition to scholarly publications, Ledewitz writes regularly in a variety of popular journals and magazines. He is the author of four books, [American Religious Democracy](#), [Hallowed Secularism](#), [Church, State, and the Crisis in American Secularism](#) and, most recently, a book from Oxford Univ. Press, [The Universe Is on Our Side: Restoring Faith in American Public Life](#).

In 1981, Ledewitz founded the Allegheny County Death Penalty Project, which he directed for 13 years. He co-founded the Western Pennsylvania Coalition Against the Death Penalty and served from 1985-1990 as secretary of the National Coalition to Abolish the Death Penalty. He is past winner of the Allegheny County Bar Association Pro Bono Service Award, the Pennsylvania Association of Criminal Defense Lawyers Liberty Award, the Marjorie Matson Civil Liberties Award and the Inaugural Dr. John & Liz Murray Award for Excellence in Faculty Scholarship in 2012, an award he received again in 2017.

Ledewitz received his undergraduate degree from Georgetown University School of Foreign Service and his J.D. from Yale Law School.
